Requirements for the preparation of abstracts of the Conference:

- the volume of the abstract is no more than 4 A4 pages together with the list of references;
- ➤ font Times New Roman, size 14, style Normal, line spacing 1.5; margins: top, bottom, left, right 20 mm;
- First line name and surname (in full) of the author (in bold, aligned to the right);
- the following lines position and place of work (study), academic degree, academic title (in italics, aligned to the right);
- the title of the report in capital letters (bold, centered in the middle of the line);
- then the text of the report, aligned in width (paragraph indentation 125 mm);
- > pages are not numbered;
- references in the text to sources should be indicated by the serial number in the list of references (through numbering), separated by two square brackets with the page of the source (if any), for example [3, p. 7];
- placement of the list of references at the end of the text in accordance with the requirements of State standards of Ukraine 8302:2015 «Information and Documentation. Bibliographic reference. General requirements and rules for compilation».
- materials are submitted in electronic form in doc, dox format.

It is prohibited to quote in the text and include in bibliographic lists those sources published in Russian in any country, as well as sources in other languages if they are published in russia and belarus. The authors are personally responsible for the accuracy of the material presented, the accuracy of the quotes, statistics, and proper names. Abstracts should not contain state secrets/official information.
